### **FAFSA Changes**

- The 2017–18 FAFSA available Oct. 1, 2016
  - Change to October 1 availability is permanent
- Earlier Year of Income Information Required
  - For 2017-2018 FAFSA, 2015 income information required

#### CHANGES TO THE FAFSA PROCESS FOR 2017–18

**SUBMIT A FAFSA EARLIER:** Students will be able to submit a 2017–18 FAFSA as early as Oct. 1, 2016, rather than beginning on Jan. 1, 2017. The earlier submission date will be a permanent change, enabling students to complete and submit their FAFSAs as early as October 1 every year. (There is NO CHANGE to the 2016–17 schedule. The 2016–17 FAFSA became available Jan. 1, 2016.)

**USE EARLIER INCOME AND TAX INFORMATION:** Beginning with the 2017–18 FAFSA, students will report income and tax information from an earlier tax year. For example, on the 2017–18 FAFSA, students (and parents, as appropriate) will report their 2015 income and tax information, rather than their 2016 income and tax information.

Here's a summary of key dates for submitting the FAFSA depending on when you plan to go to school:

# **Get Ready to File**

- Get FSA IDs now!
  - STRONGLY encourage students and parents to get their FSA ID (username and password) ahead of time
  - All students need an FSA ID
  - Dependent students will also need one parent to have an FSA ID to:
    - Use the IRS Data Retrieval Tool
    - Sign the FAFSA





### **Get Ready to File**

- Get FSA IDs now!
  - Benefit of getting FSA ID ahead of time:
    - SSA will verify info; if problem, time to resolve
    - When student signs in using his/her FSA ID, student name, SSN, and DOB will be prepopulated





### **Get Ready to File**

- Get FSA IDs now!
  - Go to <u>fsaid.ed.gov</u> to create an FSA ID and use <u>FAME's FSA ID Information Tracking Sheet</u> to keep track of FSA ID information





- Encourage students to file the FAFSA early
  - Still unsure about school deadlines
  - Some schools award aid on a first-come, firstserved basis
  - No downside to filing early
  - Must list one school but can add additional schools after the FAFSA has been filed





- Encourage families to use the IRS Data Retrieval
   Tool (DRT)
  - The 2017-18 FAFSA requires 2015 federal income information
  - Most of those required to file taxes will be able to use IRS DRT
  - To retrieve information, mailing address must be entered exactly as shown on the tax return
    - Recommend having 2015 federal income tax return(s) available when completing the FAFSA





- IRS DRT and the impact on verification:
  - According to Federal Student Aid (Jeff Baker):
    - "Applicants who use IRS DRT are very, very, very, very unlikely to be selected for verification"
- Keep in mind...
  - Certain information (assets) is "as of today,"
     so read each question and fill out accordingly

Works for ME



- Important info for 2016-2017 FAFSA filers:
  - No renewal option this year
  - Avoid providing conflicting income information
  - Student Aid Report is available for reference
  - Use IRS DRT!

#### GET READY TO FILE THE 2017-2018 FAFSA

Changes have been made to the FAFSAI Students and families can now file the FAFSA beginning on October 1. In addition, students will be able to file using an earlier year's tax information. The 2017-2018 FAFSA (used for the 2017-2018 academic year) will require 2015 income information.

#### What you need to file the 2017-2018 FAFSA

#### GET YOUR FSA ID NOW!

- The FSA ID is the user name and password students will use to access all Federal Student Aid websites, including FAFSA.gov. It takes about 10 minutes to create an FSA ID, so we recommend creating an FSA ID ahead of time. One parent of a dependent student will also need to create an FSA ID to stan the FAFSA.
- To create and learn more about the FSA ID, go to FSAID.ed.gov. Keep track of your FSA ID Information using FAME's FSA ID Information Tracking Sheet.

#### Dependent students will need the following information:

- □ Your and your parents' FSA ID
- Your and your parents' Social Security numbers
- □ Your and your parents' 2015 federal income tax returns, 2015 W-2 forms, and other records of money earned
- Your and your parents' current bank statements

#### If applicable, you will also need...

- Your driver's license (if applicable)
- Your and your parents' 2015 untaxed Income Information
- Your and your parents' current business and investment mortgage Information, business and farm records, stock, bond and other investment records
- Your alien registration or permanent resident card (if you are not a U.S. citizen)

#### Assets on the FAFSA

Many students and parents aren't required to report assets. If you are, be sure you only include assets that have to be

#### REPORTABLE ASSETS ON THE FAFSA:

- Cash, checking, and savings
- Real estate (other than home you live in).
- Financial assets, such as stocks, bonds, certificates of deposit, mutual funds, and money market accounts
- □ UGMA/UTMA accounts
- College Savings Plans, including 529 plans and Coverdell accounts (list as a parent asset)

#### NON-REPORTABLE ASSETS:

- □ The home you live in
- Rettrement plans
- Any small, family-owned businesses with less than 100 full-time employees
- The family farm (if family's principal residence and parents participate in farming operation)
- □ Life Insurance policies
- Personal possessions, such as cars and boats



#### When Is Parent Information Required?

Students are considered dependent and required to provide parent information unless they can answer YES to one of the following questions:

- □ Were you born before January 1, 1994?
- □ As of today, are you married?
- At the beginning of the 2017-18 school year, will you be working on a graduate program?
- Are you currently serving an active duty in the U.S. Armed Forces for purposes other than training, or are you a veteran of the U.S. Armed Forces?
- Do you have children or dependents who will receive more than half of their support from you between July 1, 2017 and June 30, 2018?
- A any time since you turned 13, were both your parents deceased, were you in faster care or were you a dependent or word of the courf?
- As determined by a court in your state of legal residence, are you or were you an emandipated minor or in a legal guardianship?
- A any time on or other July 1, 2016, were you homeless or at raik of being homeless?

#### Checklist items:

# Things to Keep In Mind

- Response to families who have had significant income changes since 2015?
  - 2015 income information must be used on the 2017-2018 FAFSA, even if changes have occurred
  - If income is significantly different, contact the Financial Aid Office to discuss further





# Things to Keep In Mind

- Manage expectations related to timing of award notifications
  - Many schools won't begin sending award notifications until February
  - Students need to be offered admission before an award will be sent
  - Timeframes will vary by school
  - Early aid offers will likely be estimates





# Things to Keep In Mind

- These changes are very positive!
  - Even if awards aren't sent until February, students will have more time to compare award packages
  - We'll soon release our revised What Happens Next with additional information to help families compare awards
