# Let's start by talking about the FSA ID!





- The FSA ID allows students to access FSA Web sites, including FAFSA on the Web.
- It is also the fastest way for students and parents to sign the FAFSA.
- An FSA ID is made up of a username and password and can be created at fsaid.ed.gov.

### **Creating an FSA ID**

- Go to: fsaid.ed.gov
- As with the retired PIN, EVERY STUDENT and ONE PARENT of a dependent student will need an FSA ID to sign the FAFSA electronically.
- Defaults to "Create An FSA ID"
- Click on "Manage My FSA ID" to view or update info.

Works for ME V

- It is recommended that students and parents obtain FSA IDs ahead of time.
- Each FSA ID takes about 10 minutes to create.
- If a student is ready to do the FAFSA but doesn't have an FSA ID, have the student create the FSA as the first step in the FAFSA process.





- Critical that information being entered is correct (especially name, social security number, and date of birth)!
- Write down the information used when creating the FSA ID (use FAME's <u>FSA ID Information</u> <u>Tracking Sheet</u>).
- An email address and mobile phone number can only be used once (student and parent can't use the same ones).

- Students shouldn't use their high school email address if they have an alternative.
- It is important to have access to mobile phone and/or email when creating the FSA ID.
  - Secure code will be sent (and then retrieved and entered) resulting in a verified mobile phone/email.
  - Having a verified mobile phone and/or email will make retrieval of username and passwords easier.

- The FSA ID can be used immediately to access and sign the FAFSA.
- However, the FSA ID can't be used to update or correct the FAFSA or enter any other FSA websites until it has been verified with the Social Security Administration (1-3 days).

#### **Special Circumstances**

Important: You told us that you think you have a special circumstance and are unable to provide parental information. Before we allow you to proceed and skip the parental section of your FAFSA we must advise you of the following:

Under Federal law to the extent your family is able, they are primarily responsible for paying for your college expenses. To determine how much your family can afford to pay towards your college expenses, we must collect your financial information and your parents' financial information.

However, Federal law allows for some exceptions, if you have a special circumstance. The following are <u>examples</u> of some special circumstances where you may submit your FAFSA without providing parental information:

- · Your parents are incarcerated; or
- · You have left home due to an abusive family environment; or
- You do not know where your parents are and are unable to contact them (and you have not been adopted).

But not all situations are considered a special circumstance. The following are situations that would not be considered a special circumstance:

- · Your parents do not want to provide their information on your FAFSA; or
- Your parents refuse to contribute to your college expenses; or
- Your parents do not claim you as a dependent on their income taxes; or
- You do not live with your parents.
