Keynote: FAFSA Simplification

Presenter: Mila Tappan, College Access and Outreach Manager, FAME

FAFSA simplification is coming and will result in the most significant changes to the FAFSA in the last 30 years. In this session we'll share an overview of upcoming changes, including the move from the Expected Family Contribution (EFC) to the Student Aid Index (SAI), expansion of how Pell Grant eligibility will be determined, and the impact of the use of the Direct Data Exchange to obtain federal tax information.

FAFSA Simplification: The FSA ID, Multi-factor Authentication, and the Direct Data Exchange with the IRS Presenter: Mila Tappan, College Access and Outreach Manager, and Nikki Vachon, College Access Counselor, FAME

Some of the most significant changes to the FAFSA are a result of how federal tax information will be obtain from the IRS. We'll be saying goodbye IRS Data Retrieval Tool and hello Direct Data Exchange. This change in process will impact everything from the FSA ID (who needs one and the role of authentication) to which questions students will see on the FAFSA. It's going to take a bit to get our heads around these changes so we encourage you to join us to get a head start!

Scholarship Workshop Demonstration

Working with Stranded Youth

Students trying to complete the FAFSA sometimes face barriers that leave them stranded during the process; they may have a parent(s) refusing (or unable) to provide information, they might have tricky circumstances at home, fall into a population of ineligible students etc. In this session, we'll explore situations that might make students feel stranded in the aid process and ways to get them unstuck and on to college.

FAFSA Simplification: FAFSA Formula and Process Changes

The change to determining Pell Grant eligibility is just one of the many changes that will impact financial aid eligibility. FAFSA formula changes also redefine who the parent is on the FAFSA, what assets and untaxed income are required on the FAFSA, the impact of multiple children in college, and more. The process for students with unusual circumstances who can't provide parent information will also be changing (for the better!). We'll discuss the good, the not so good, and everything in between!

Collaboration between Adult Education and District Partners – A Model for Serving At Risk Students

Collaboration with district partners is a critical component of any adult education program. In this session we will discuss our work to create a 'pipeline' to adult education services. We will discuss strategies and messaging that effectively communicate what we can do for students who are at risk of dropping out of high school or need post-secondary transitional support. We will discuss models used both for high school completion and for "summer melt." Participants will learn how building relationships between adult education programs and our secondary partners results in a win-win situation for students, adult ed programs, and the districts who support them.
