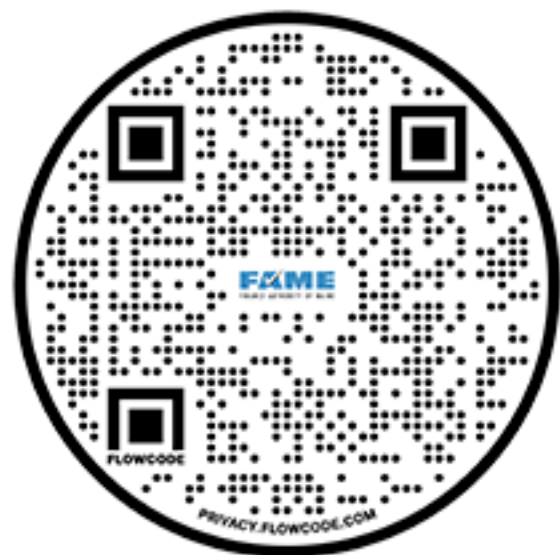

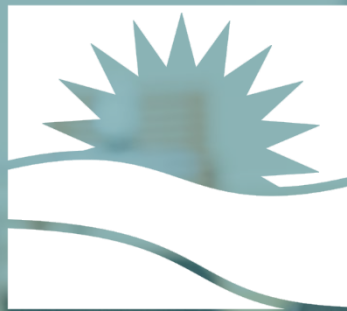

Short-term workforce training through Maine's community colleges

Stackable Workforce Training

Pre-Hire

Short-Term Training

Designed to equip underemployed individuals with the skills and knowledge needed to secure employment. Designed to meet the needs of regional employers and developed in collaboration with business and industry leaders. Short-term pre-hire training programs offer pathways into certificate and degree programs at Maine's community colleges.

Goal: 19,342 Students

Maine employers can sometimes double their training budget for their frontline workforce. By joining the Compact, employers can access up to a \$1,200 match per employee per year to provide additional skills and knowledge to enhance their performance, advance their careers, and adapt to changing job requirements.

Enabling more Mainers to access opportunities to advance their education and careers. Alfond Center Scholarships provide 50% off two community college courses each semester for working Mainers starting or pursuing a certificate or a degree program. Students can access 4,000 courses statewide to customize their career pathway.

Eligibility

- 18 years old and above
- First generation immigrant in the BIPOC community
- Income at 100%AMI or less
- Net asset of or less than \$10,000
- Basic money management required

Education asset

- Someone else can enter the program on behalf of the student
- The school needs to be in Maine and it must be accredited
- If 1 year of saving is chosen, student can withdraw two times to cover for two semester

To Apply

- Fill out the Application
- Submit:
 - 2 paystubs (if you are paid bi-weekly)
 - Bank Statement
 - Tax Return
 - Household Budget

Equitable Scholarships for Equal Outcomes



Who We Serve:

The Promise Scholarship is designed to help underserved young achievers from Maine overcome financial, academic, social, and cultural barriers, remain in school, and graduate in four years with minimal debt – prepared to make their own contributions to Maine’s social and economic well-being.

Specifically, students are eligible who:

- are residents of Maine
- demonstrate financial need
- plan to enroll full-time
- are a first-generation college student
- demonstrate academic promise, and
- demonstrate commitment to community service and civic engagement

Serving 100 Scholars

Promise Scholars come from all across Maine and are generally referred by partnering youth-serving organizations including:

- Boys & Girls Club of Southern Maine
- Camp Susan Curtis
- Make It Happen! Portland Public Schools
- Olympia Snowe Women's Leadership Institute
- JMG
- TRIO Upward Bound
- 4-H Cooperative Extension

Among all Promise Scholars...

- 94% are first-year students
- 79% are first-generation college students
- 71% are eligible for a Federal Pell Grant
- 64% identify as female
- 54% identify as underrepresented minorities



More than a Scholarship.

The Promise Scholarship awards equitable, renewable, top-off scholarships that meet 100% of demonstrated need in covering the cost of tuition, fees, housing & meal expenses.

Additionally, scholars...

- Attend our Immersion Week Experience that occurs prior to the fall semester
- Meet with Promise Peer Leaders each month throughout their first year
- Receive extra support in advising, goal setting, and career & experiential learning opportunities
- Have access to a textbook library, emergency, and support funds



Since 2018, Promise has awarded over \$2.1 million dollars in direct student aid

Sense of Belonging & Connection

Students who feel integrated into their campus are significantly more likely to seek out tutoring, faculty office hours, and mental health services. More so, when scholars feel a sense of belonging they are more likely to take on campus leadership roles.

Promise Reaching New Heights!

The Promise Scholarship is built on a simple but transformative premise: when scholars are provided with adequate resources, the space to focus deeply on their academics, and a genuine sense of belonging and purpose, they don't just succeed—they thrive.

The Power of Promise:

- 92% or more of scholars return for their sophomore year for the last four years (+19.9%)
- 79% of scholars from the class of 2025 graduated within four years (+44.9%)
- 45% of scholars from the class of 2024 graduated within four years (+16.8%)

If you're not sure of your eligibility, you can use our interactive eligibility questionnaire to help you determine your status:

Interactive Eligibility Questionnaire:

1.) Are you a US Citizen?

You indicated you are not a U.S. citizen, but you may be an eligible noncitizen. We'll ask a few more questions to help you find out.

2.) Are you a U.S. national (includes natives of American Samoa or Swains Island)?

3.) Are you a U.S. permanent resident with a Form I-551, I-151, or I-551C (Permanent Resident Card, Resident Alien Card, or Alien Registration Receipt Card), also known as a "green card"?

- U.S. Citizen
- Eligible Non -Citizen

- Undocumented individuals
- International Students

Sample Identification Cards

Permanent Resident – Known as the Green Card

The **Permanent Resident** or **Green Card** is an identification card indicating the holder's status to live and work in the USA permanently.



I-94

The Arrival and Departure Record is the I-94, in either paper or electronic format, issued by a Customs and Border Protection (CBP) Officer to foreign visitors entering the United States. After April 30, 2013, most Arrival and /or Departure records will be created electronically upon arrival.



Work Permit

An Employment **Authorization** Document (**work permit**), or. An employment-related visa which allows you to **work** for a particular employer.
